### Juneteenth celebration set for this weekend

MURFREESBORO -- The City of Murfreesboro and the Chamber of Commerce are cosponsoring the second annual Juneteenth celebration in Murfreesboro.

Juneteenth is actually Thursday, June 19, but activities will be held in advance starting this Friday, June 13.

That night a meet and greet will be held for all attendees and the public at the Murfreesboro Municipal Building starting at 5 p.m.

On Saturday morning, June 14, the festivities will kick off with a parade down Washington Avenue to the Murfreesboro City Park. The parade will begin its procession starting at 10 a.m., with lineup beginning at 9:45 in the Harvill Insurance parking lot.

From 11 a.m. to 2 p.m. activities will be held at the park, including an opening speech by Jeffery Rhymes. Following will include a domino tournament, spades, a bounce house, live D.J. and lunch of hot dogs and watermelon.

Later that night, at 8 p.m., a street dance will be held on Mauney Street in Murfreesboro.

On Sunday, all attendees and the public will be invited to church services at the Mauney Street Church of Christ starting at 9 a.m.

#### JUNETEENTH HISTORY

According to the Congressional Research Service, Juneteenth celebrates the end of slavery in the United States. It is also known as Emancipation Day, Freedom Day, Jubilee Day, Juneteenth Independence Day, Black Independence Day, and, by statute, Juneteenth National Independence Day.

On June 19, 1865, Major General Gordon Granger arrived in Galveston, TX, and announced the end of the Civil War and the end of slavery. Although the Emancipation Proclamation came 2.5 years earlier on January 1, 1863, many enslavers continued to hold enslaved Black people captive after the announcement. Juneteenth became a symbolic date representing African-American freedom.

Juneteenth became a federal holiday on June 17, 2021. All 50 states and the District of Columbia recognize Juneteenth as a holiday or observance, and at least 28 states and the District of Columbia have designated Juneteenth as a permanent paid and/or legal holiday through legislation or executive action.

"I hope everyone will come have lunch,


meet and visit with the authors, and help us celebrate the release of our patriotic anthology mystery book. There is something for all ages," said Richards.

## Drunken day at Caddo River leads to police chief being punched

MURFREESBORO -- A Glenwood man has been charged in Pike County after an intoxicated incident on the river last month when he allegedly punched the local police chief.

Kevin Taylor, 39, was charged with second-degree battery Monday involving a May 13 incident where the Glenwood Police Department was called to the Highway 8 bridge over the Caddo River about two males who were intoxicated and caus-

When an officer arrived, he located one male lying face down in the river and the other male attempting to drag him out. One of the males involved, later identified as Caleb Cates, fled the scene toward Elm Street. The officer reported Cates was "highly intoxicated" and stated his friend, Kevin Taylor, needed help under the bridge.

Taylor was also "highly intoxicated" when he was located and was trying to fight his friend. When Glenwood Police Chief Greg Harmon arrived to de-escalate the situation, Taylor allegedly punched the chief. With the help of two officers and a first-responder, Taylor was placed in handcuffs. Harmon was slightly injured in the ruckus including bruised ribs.


After an evaluation by an ambulance crew, Taylor was transported to the Pike County jail. Taylor has yet to have a court

On June 5, Robert Glen Wells, 37, of Mena, was charged in Pike County with felony forgery.

According to case information, Wells is accused of passing counterfeit money, all with the exact same fake serial numbers, at the John Plyler Home Center, and possibly other places in Polk County. Surveillance video led the Glenwood Police Department to Wells.

Wells had yet to have a court date.

#### Q: Do I use cold or heat for muscle injuries and pain?

A: Whether to use cold or heat is a common guestion for home treatment of minor joint or muscle injuries and pain. The answer is often both.

Cold is best used with new injuries, particularly in the first 48-72 hours. Cold reduces inflammation and swelling, and it also reduces pain by numbing the affected area. Cold can also be effective with conditions such as gout or tendinitis. Cold treatments should be for no more than 20 minutes at a time.

Heat can be used to relax tightened muscles and stimulate blood flow to the area, which promotes healing. For new injuries, heat should be used after the initial 48-72 hour period of cold treatment. Heat

can also be used prior to certain activities to warm joints and

Both treatments can be used effectively at home to resolve many minor issues. Once inflammation and pain subside using cold, heat can help manage joint and muscle stiffness in the affected area. If the problem persists after using one or both treatments, make an appointment with your health care provider for further direction



## Take note of the rare strawberry moon as final full phase of spring

The final full moon of spring will occur on June 11. This month's moon is now called the Strawberry Full Moon, but Native American tribes over time have also called it the Berries Ripen Moon, Green Corn Moon and Blooming Moon. The ancient Ĉelts called it Horse Moon and Rose Moon.

The full moon of June 2025 is a rare one. No, it will not be strawberry red. It is rare because it will cross from southeast to southwest above the southern horizon at only about 20 degrees. The last time it was this low was in 2006

Briefly, the reason it doesn't rise high is because the Sun is near Summer Solstice when it is highest in the sky, and also because Earth's orbit is almost the farthest away from the Sun (aphelion peaks in July). It so happens that the Moon is also near its most distant from the Earth. So, it will be low in the sky and a "micro"

Look for the star grouping called the Summer Triangle rising in the northeast as darkness comes. Mentioned before, this is a triangular asterism made up of the three brightest stars of their respective constellation. Altair of the constellation Aquila the Eagle is the last of the three to rise. It is a very curious star because astronomers estimate that it has a spin rate that is on the edge of its gravitational cohesion. The Sun makes a full rotation in 24 ½ days. Altair takes only 10 hours to make one rotation, which is why it is flattened and looks a bit like an M&M.

# Mount Ida missing person found dead, suspect in custody

MOUNT IDA - A Mount Ida man has been charged with murder following an investigation into a report of a missing person Saturday,

Billy George Walden, age 53, of Mount Ida, Arkansas, has been formally charged in an ongoing investigation by the Arkansas State Police and the Montgomery County Sheriff's Office. Walden was initially arrested Saturday, June 7, and charged with Second-Degree Battery, Kidnapping and Tampering with Physical Evidence. He also faces charges of Fleeing and Resisting Arrest.

Events which led to his arrest began Saturday, June 7, when the Montgomery County Sheriff's Office (MCSO) received a report of a missing person according to an initial statement released by the sheriff's office Sunday. The release reported that through the course of the investigation deputies began to suspect the possibility of foul play. Sheriff Thomas contacted the Arkansas State Police (ASP) Criminal Investigation Division (CID) to assist in the investigation.

The ASP CID released a statement Monday stating when Special Agents arrived, they found evidence of foul play. A suspect was identified and taken into custody on Saturday, June 7, 2025. Human remains were discovered near the suspect's Mount Ida property.

The suspect was identified as Billy George Walden Monday, June 9, in a social media post. The victim has not been identified at this time.

Bond has been set at \$1,000,000.00. Walden will be formally arraigned on the charges in Montgomery County Circuit Court at a later

Additional information will be released as it

becomes available. The investigation is ongoing. All charges listed are merely allegations and all persons mentioned are presumed innocent until proven guilty in a court of law.

## Report of escapee visiting area ultimately go unfounded

GLENWOOD -- A manhunt in North Arkansas for a convicted murderer and rapist led to unconfirmed reports of him being spotted in Pike County last week according to the Pike County Sheriff's Department.


Grant Hardin, a former chief of police in North Arkansas, escaped from the Arkansas Department of Corrections facility in Calico Rock on May 25, 2025 while disguised as a correctional officer. He was serving a 30-year sentence for murder and rape. He pleaded guilty to the murder of James Appleton in 2017 and was later convicted of a 1997 rape involving an elementary school teacher in Rogers, Arkansas.

A statewide All Points Bulletin was issued as a manhunt was launched to capture the fugitive. Last week the Pike County Sheriff's Department reported that there had been a report of a possible sighting of someone matching Hardin's description at the Family Dollar Store in Delight.

The sheriff's office reported that after reviewing video footage they were unable to confirm if the individual spotted was the escaped inmate. They reiterated that they could not confirm the identity of the person identified as possibly being Hardin.

The manhunt for Hardin, known as "The Devil of the Ozarks," included local, state, and federal agencies. The moniker was the result of a documentary about the charges that led to his arrest, conviction and incarceration.

He was found by Arkansas LEOs and the U.S. Border Patrol Friday, June 6, 2025, near Moccasin Creek in Izard County. He was found a mile and a half from the prison he had escaped from earlier. While the sighting in Delight was unconfirmed, in light of the location he was found it is unlikely that he was the person spotted in Delight the week before.





## ARDOT announces recent scam for state residents

LITTLE ROCK -- The Arkansas Department of Transportation (ARDOT) warns Arkansans to be cautious of fraudulent texts asking for personal information or payment information. AR-DOT has received reports of fraudulent text messages posing as the "Arkansas Vehicle Administration" to collect payments for traffic violations. These scam messages include fake links that appear to come from ARDOT, and some even use real ticket

The Arkansas Department of Finance and Administration (DFA) is separate from ARDOT. There is no validity to these messages

"DFA will never send you a text regarding a traffic ticket," DFA spokesperson Scott Hardin said. "Please ignore it and warn friends and family. Thousands of Arkansans are receiving this text today."

These fraudulent messages come on the heels of a previous texting scam relating to toll roads. In February 2025, Arkansas Attorney General Tim Griffin alerted Arkansans to a scam targeting mobile phone users through fraudulent text messages. Those behind the text messages were posing as toll service providers to steal personal information and trick recipients into making fake payments.

"If you get one of these texts, please fill out the robocall reporting form on my website, and do not send payment to any entity that only contacts you via text," Attorney General Tim Griffin





## **Arkansas first in election integrity**

LITTLE ROCK – Arkansas ranks first in the nation in election integrity, according to the

most recent study by the Heritage Foundation.

Last year Arkansas ranked number eight. At a press conference at the Capitol, the Governor, the Secretary of State and members of the legislature announced the newest ranking.

They attributed the state's moving up in the rankings to prioritizing in recent years the passage of laws that secure the integrity of voter registration and processing ballots.

According to one senator, the Heritage Foundation rankings have long been the gold standard for comparing how well states prevent voter fraud.

Arkansas scored 91 out of 100 on the recent scorecard, including 20 out of 20 in the category of voter ID implementation. We scored three out of three in granting access to election observers, four out of four in verification of citizenship of voters, three out of three in requiring identification of people who assist others to vote and three out of three in prohibiting election officials from receiving pay or benefits from private sources.

Arkansas scored six out of six in how we monitor voter registration to prevent fraud. For example, Arkansas does not allow registration on the same day as elections. Requiring voter registration ahead of an election allows more time to verify the accuracy of applications.

However, Arkansas scored 26 out of 28 in the category that measured the accuracy of voter registration lists. One negative score was for not including photographs of voters on the lists of registered voters, where they are kept electronically.

The legislature's approval of Act 840 of 2025

may correct a negative score in the Heritage rankings. The act allows the Secretary of State to share voter registration lists with federal courts, which use them for jury selection. In return, the courts will notify the state of ineligible voters such as non-citizens, convicted felons, dead people or non-residents of the state.

The Heritage Foundation scorecard did not include a package of bills enacted earlier this year that prevent deceptive practices when canvassers collect signatures in order to place an issue on the ballot.

However, the governor specifically mentioned several of them, such as Act 218 of 2025 to require canvassers to inform people, before collecting their signatures, that petition fraud is a Class A misdemeanor. The disclosure could be verbal, or in a separate written document that would be shown to people before they sign

She also mentioned Act 240 to require canvassers to view a photo ID of each person signing the petition. If canvassers are unable to verify someone's identity, they may not collect a signature.

The governor mentioned another bill that strengthens the protections of the signature-gathering process - Act 241. It requires canvassers to submit a sworn statement that they have complied with all state laws governing the collection of signatures, and with the Constitution. Unless canvassers submit the sworn statements, any signatures they submit will not be counted.

The Secretary of State listed measures to ensure the accuracy of voter registration lists, such as partnering with credit bureaus to determine that people actually live where they say they do on applications. Agreements with other states reveal whether people are registered in more than one state.
